

I have read and reviewed every one of his books. Each book gets better. This is really an interesting book. As I was thinking about it when I was about halfway through I realized that more than any other of his books, the real main character in this book is the story itself as opposed to any of the individual players each player is important of course but the story is what really carries the day. The story involves the murder of an employee of a securities firm which is obviously involved in a money laundering scheme for a Mexican drug cartel. The alleged murderer is none other than the beautiful investigator Maddy. There is always a story within a story in his books but in this one it is more like an onion with many layers. You know it's going to come out all right but can never figure out exactly how we will get there. In this book there are competing interests between a federal investigation of the corrupt securities firm and the defense of what is obviously an innocent civilian. The billionaire, Vivian Corwin gains new prominence in this book as does The retired Minneapolis police officer, Tony Cavaleri. As usual, Carstens, has very crisp transitions. Apparently his characters will have eating disorders because virtually every meeting that occurs happens in restaurants, with the occasional pizza party at the office. As the lawyer and now judge myself, I can say that while these stories set in a courtroom and the law is very accurate, the book never bogs down in legal minutia and the courtroom passages are crisp and neat. This is a very enjoyable and easy read and I heartily recommend it.

This is an excellent book featuring both a terrific plot and an interesting story to reveal the plot. The characters have positive values and thus are very easy to like. A lawyer faces the challenge of defending a good friend from a murder charge. Unknown to them there are several federal
