

Good to read the other side

In watching the documentary *Making a Murderer*, I was struck by how slanted it was toward the defense. It was obvious that the documentarians were not giving the whole story but rather were focusing on the argument that Steven Avery had been framed. In searching for more information, I came across Griesbach's book and chose to read it because, while Griesbach is a prosecuting attorney, he is also active in the Wisconsin Innocence Project and is knowledgeable and concerned about miscarriages of justice. It seemed likely, therefore, that of all the accounts of the crime and trial, his would be the most objective. He provides a thorough critique of the documentary and the defense strategy and a thorough review of evidence, including much that was not revealed in the documentary. It found it a very convincing and compelling read.

Purporting to have evidence on alternate suspect, the claim never really comes to fruition as Mr Griesbach's whipsaws between near certitude of their guilt and, plugging his previous work on Steven Avery's prior conviction, what his role is/was vis-a-vis this information and giving it to

Kratz.What is new in this account and not seen or discussed in Making A Murderer is the fact that Brendan Dassey provided critical evidence to the police before forensics was able to determine it scientifically. Leading questions or not, the police didn't lead him to this info. And his mom, despite her indignance over her son's interrogations, actually took him back to police station after school on March 1st to continue his confession. Mr Greisbach's best contribution to the body of work comes in the legal discussion of what the courts look for in weighing confessions - voluntariness and truth. In that order.Another major point NOT brought up during trial but every bit as disgusting as Steven Avery's previous deviant behaviours was the ongoing sexual abuse of his (step) niece. Mr Greisbach does a fair job of discussing the legal reasons why these bad acts were not admissible.His point seems to be, throughout this book, that Making a Murderer wasn't completely honest in its editing (duh) and it should have been. The repercussions on the Manitowoc Sheriff's Dept and its personnel weren't fair and Mr Greisbach felt the need to tell Netflix viewers that they were all manipulated and whipped into a frenzy by documentarians with an agenda.
