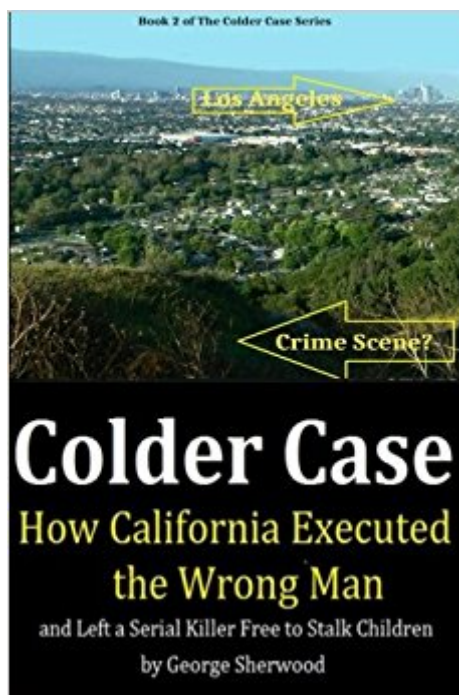

In The Colder Case Series, Uncivil Twilight is the 1925 case about the trial of S.C. Stone for the murders of the Martin sisters. Colder Case is the 1937 case and the trial of Albert Dyer for the murders of Melba and Madeline Everett and their friend Jeanette Stephens. Snake Avenue is a similar 1931 case about the murder of Virginia Brooks in San Diego, which is still unsolved. In the

Court of Deadly Assumptions is about another 1937 case, the trial of Samuel Elmore for the murder of Joan Kuleba. There was no intention of writing more than Colder Case, but research revealed too many similar murders of children and they had to be followed. None of these are light, entertaining reading.Â They are real cases with gruesome facts as reported in the news and official records. The testimony can be difficult at times and that made these cases more vulnerable to wrongful convictions because of the demand for swift punishment.

The author gives compelling evidence that the murderer or murderers got away with murder and an innocent man was hanged.

I love true crime novels, and it is certainly true that fact is often stranger than fiction. The book seems well laid out and follows a logical procession. It seems a little long at 321 pages, but when I reached the end the story didn't. The title promises closure to the issue of innocence, however, in my opinion, in this area the book doesn't deliver. This book definitely proposes a very reasonable doubt and puts forth a seemingly more likely perpetrator with a good deal of factual supposition and a skillful interpretation of facts. But it also seems to bolster the idea that the accused might not have been innocent and might not have acted alone. I believe the author did prove enough doubt that the man should not have been hanged. Had he not been executed we might now know the truth of what happened to those three little girls. While the book may not totally convince me of Dyer's innocence it is a fascinating. I enjoyed learning about this case that I had never heard of before. Well written and nicely ordered, it was well worth both my money and my time. This seems to be part of a series by this author and I will absolutely have to read those, too!
